
Our Methods

Personal Genetic Testing



- e.g. 23andMe
 - \$99
 - 240+ genetic disease and trait markers
 - 400,000+ genotyped customers
- Reports provide
 - Disease predictions
 - References to literature
 - Lifestyle advice
 - Links to online communities
 - Ancestry information





Lifestyle (Inputs)

Invisible Algorithms



- Testing is selective
 - e.g. BRCA and breast cancer
- Star ratings hide genetic complexity

- Shifting toward a genetic epistemology
 - Ontic occlusion: How does this way of knowing block other forms of knowledge (Knobel, 2010)

- The self as algorithmic performance
 - "The more you know about your DNA, the more you know about yourself."

- I am my genome
 - Defined by genetic mutations
 - A collection of disease risk
- Membership in genetic communities
 - Family as genetic lineage
 - Biosociality: communities based on markers (Rabinow, 1992)
